### MARICOPA COUNTY ENVIRONMENTAL SERVICES DEPARTMENT ENFORCEMENT PROCEEDINGS FOR DECEMBER 2006

The Environmental Services Department suspended the operating permit(s) for the following facilities/establishments or individuals in December 2006. A permit suspension may occur immediately for serious environmental health code violations, which pose a major health hazard. The facility/establishment would not be permitted to operate until a subsequent inspection shows the health hazard has been removed and/or corrected. Permit numbers that begin with a “P” are bathing facilities (i.e. swimming pools and/or spas). All other permits listed are Food Establishments.

The Environmental Services Department uses one of the following methods of legal action to enforce the Environmental Health Code.

- **A Permit Revocation** may be initiated against a facility/establishment that has not demonstrated compliance or has been found in violation of any applicable code. Permit revocation may also be initiated against trailer parks, hotels, semi-public swimming pools, and retail food establishments.

- **A Permit Suspension** may occur immediately for serious environmental health code violations, which pose a major health hazard. The facility/establishment would not be permitted to operate.

- **Citations (Class III Misdemeanors)** are issued for violations of the health code. The citation directs the defendant to appear for arraignment in Justice Court.

- **Cease and Desist Orders** are issued for serious violations of the environmental health code. The violation must be corrected immediately and a hearing may be requested. Disregarding the order will result in injunctive action in Maricopa County Superior Court.

- **Notice of Violation and Demand for Compliance (NOV)** are issued for serious violations of the environmental health code. The violation must be corrected within a specified timeframe and a hearing may be requested. Disregarding the order will result in a Compliance Order being issued by the Department.

- **Compliance Order** is issued for violations of the environmental health code and a NOV. The violation must be corrected within a specified timeframe and a hearing may be requested. Disregarding the order will result in action in Maricopa County Superior Court.
